Switches can only be undertaken under the current name of your holding in the unlisted class. You cannot change the ownership of how the units are held using this form.

Prior to completing this Form, please consider the current Investors Mutual Concentrated Australian Share Fund (Quoted Managed Fund) Product Disclosure Statement, Target Market Determination and Investment Guide, where applicable, which can be found at our website iml.com.au. If you do not have an existing holding in the Listed Class, the proceeds of the switch will be registered as an issuer sponsored holding with a Security holder Reference Number (SRN) issued by the registry. The registry will provide you with confirmation details of the transaction.

If you do have an existing issuer sponsored holding (SRN) or broker sponsored (HIN) for the Listed Class, you will be required to provide details of that holding in Section 2 below, otherwise the switch will be registered under a new SRN.

You will need to contact your broker / platform to transfer issuer sponsored holdings to a broker sponsored holding (HIN).

Switching between classes may also give rise to tax consequences and it is recommended that you check the tax implications with your tax adviser before switching.
